Sales Overview

In October 2021, the Group together with its joint ventures and associates achieved a contracted sales amount of approximately RMB7.602 billion and a contracted sales area of 597,487 sq.m. The average selling price for October 2021 was RMB12,723 per sq.m.

For the ten months ended 31 October 2021, the Group, together with its joint ventures and associates achieved an accumulated contracted sales amount of approximately RMB90.242 billion and an accumulated contracted sales area of 6,257,041 sq.m, representing a year-on-year increase of 13% and 15%, respectively. The average selling price for the ten months ended 31 October 2021 was RMB14,422 per sq.m.

Land Bank

As of 31 October 2021, the Group together with its joint ventures and associates owned a land bank with an aggregate planned GFA of approximately 40.42 million sq.m.

No new land parcels were acquired in October 2021.
